

At the completion of our Clark County backroads tour, the 18 attendees enjoyed a snack at the home of the tour leaders John and Dianne Earnest while our hostess read the answers to the points of interest questions on the tour notes.

Jerry Lane thanked our tour leaders Dianne and John Earnest for organizing this month's tour. He also thanked Roger Green for his service as Vice President and Corley Wooldridge for accepting the appointment to that office.

Jerry reported on Bob Rusunen stating he is recovering well after surgery and Kathy Green reported she is doing good after recovering from issues due to heavy smoke in our area.

Corley Wooldridge asked the group for additional response to the tour questionnaire he mailed out to the club members earlier in the month. ## Volcano A's Tour Survey Results

First, the response was not too large, maybe most people are not interested in tours, maybe they are too busy to respond, or maybe they just want to follow along with whatever the group decides. Whatever, we appreciate the responses that we did receive. We also went over the survey questions at the short meeting following Dianne and John Ernest's recent tour. This is a compilation of those responses, or at least the way I heard and read it...

- 1) People seem to like every type of tour, but are more interested in tours that avoid cities and traffic.
- 2) Most people like local tours of 2-3 hours in length max.
- 3) If a tour is longer than about 3 hours, several people commented that they would prefer an overnight tour to a long single day tour.
- 4) We should compile a list of previously run tours so we can determine if there is interest in re-running some tours. (Your help is needed for this since no one person has attended them all.)
- 5) Regarding the Covid-19 virus and tours, it seems that these tours are about the only activity the club can perform at this time, and most people want to continue with having tours when possible. People thought that we can limit our exposure with masks and safe distancing to an acceptable level.
- 6) Several people would like to have detailed route instructions for tours. Some, not so much, appreciating the surprise of following the leader. Knowing how much work it can be putting together maps and instructions, it will continue to be "optional", but we will try to do more of that.
- 7) Most 'loved' the Trout lake tour, but some mentioned it was too long for one day and they might have preferred an overnight with it.
- 8) The ice cream tour was pretty much OK with everyone. The length seemed about right to most. Again, people mentioned that they like country drives and they don't have to have a particular destination, but it is nice if they do.
- 9) No one offered to step up to plan a tour, and few suggestions were offered. Come on guys, we need your assistance on this one...
- 10) Again, your help is needed with ideas, planning, etc.
- 11) Cost of tours does not appear to be an issue with anyone. A comment made was along the lines of; "If you can afford a collector car, you can afford tours."
- 12) Of those who responded to the survey, everyone but one like doing tours on weekdays. (Austin is still working weekdays.) We will continue to do tours on weekdays and weekends whichever makes sense.



Veterans Day is a well-known American holiday, but there are also a few misconceptions about it — like how it's spelled or whom exactly it celebrates. To clear some of that up, here are the important facts you should know.

### **Veterans Day does NOT have an apostrophe.**

A lot of people think it's "Veteran's Day" or "Veterans' Day," but they're wrong. The holiday is not a day that "belongs" to one veteran or multiple veterans, which is what an apostrophe implies. It's a day for honoring all veterans — so no apostrophe needed.

### **Veterans Day is NOT the Same as Memorial Day.**

A lot of Americans get this confused, and we'll be honest — it can be a little annoying to all of the living veterans out there. Memorial Day is a time to remember those who gave their lives for our country, particularly in battle or from wounds they suffered in battle. Veterans Day honors all of those who have served the country in war or peace — dead or alive — although it's largely intended to thank living veterans for their sacrifices.

### **It was originally called Armistice Day, commemorating the end of World War I.**

World War I officially ended when the Treaty of Versailles was signed on June 28, 1919. However, the fighting ended about seven months before that when the Allies and Germany put into effect an armistice on the eleventh hour of the eleventh day of the eleventh month.

For that reason, Nov. 11, 1918, was largely considered the end of "the war to end all wars" and dubbed Armistice Day. In 1926, Congress officially recognized it as the end of the war, and in 1938, it became an official holiday, primarily a day set aside to honor veterans of World War I.

But then World War II and the Korean War happened, so on June 1, 1954, at the urging of veterans service organizations, Congress amended the commemoration yet again by changing the word "armistice" to "veterans" so the day would honor American veterans of all wars.


### **For some inexplicable reason, the bill set Veterans Day commemorations for the fourth Monday of every October.**

On Oct. 25, 1971, the first Veterans Day under this new bill was held. We're not sure why it took three years to implement, but not surprisingly, there was a lot of confusion about the change, and many states were unhappy, choosing to continue to recognize the day as they previously had — in November.

### **Other countries celebrate it, too, in their own ways.**

World War I was a multinational effort, so it makes sense that our allies also wanted to celebrate their veterans on Nov. 11. The name of the day and the types of commemorations differ, however. Canada and Australia both call Nov. 11 "Remembrance Day." Canada's observance is pretty similar to our own, except many of its citizens wear red poppy flowers to honor their war dead. In Australia, the day is more akin to our Memorial Day.

Great Britain calls it "Remembrance Day," too, but observes it on the Sunday closest to Nov. 11 with parades, services and two minutes of silence in London to honor those who lost their lives in war.


### BILL TRUESDELL CONCORD, CALIFORNIA



## Jim's technical tip

### Rattles Under the Hood

Very few things are as annoying as a persistent rattle under the hood while you drive your Model A. Of course it stops when you pull over and look under there!

That rattle is driving me CRAZY!

Here are some things that I have found over the years can sound like a rattle under the hood:

- The radiator support rods. They come loose at the radiator or at the firewall.
- The engine pans. Just one loose bolt/nut can rattle like crazy (hard to find).
- Hood support/prop brackets. The ones that "fold in" will rattle if closed all the way; open it back up  $\frac{1}{2}$ " to separate the halves from touching.
- Brake rods. Jiggle them by hand. You may need to install some of the oversize clevis pins to tighten things back up, or replace the return/anti-rattle springs.
- Tools and things under the seat. (I found a large screwdriver once in my side curtain pan, way in the back, that was causing a rattle that I chased for 2 years!)

I hope this helps you track down that annoying rattle. In a future Tech Tip, I will cover potential sources of other annoying noises in your car. Until then, "Have a Model A Day!" Jim


